ADMINISTRATIVE ORDER S-2012-001

ADMINISTRATIVE ORDERS UPDATE

Florida Rule of Judicial Administration 2.215(e)(3) requires the chief judge to direct an annual review of all administrative orders of a general and continuing nature to ensure they remain current. The Thirteenth Judicial Circuit posts all administrative orders of a general and continuing nature on the court's web site (<u>www.fljud13.org</u>). Certain administrative orders not posted on the court's web site and no longer necessary have not been formally rescinded. It is necessary to formally rescind administrative orders that are no longer necessary or have already been superseded.

For purposes of this administrative order, the following reasons have the following meanings: "No longer necessary" means that subsequently enacted laws or rules adequately address the subject matter of the administrative order or that the administrative order is obsolete; this term also applies when provisions of an administrative order have expired, have become obsolete, have had their effect, have served their purpose or have been implicitly repealed or superseded. "Superseded" means that a subsequent administrative order specifically addresses the same subject matter and changes the procedure so that the administrative order is replaced.
