#### About Hiring an Attorney

The best way to find an attorney is through the recommendation and personal experience of trusted friends. The important thing is to find a lawver that you trust. This sounds obvious, but it is essential. You will be giving your lawyer the power to make important decisions for you, and you must believe that he or she is working for your best interest. Your lawyer should have experience in the area of law you need. Find out how much the lawyer will charge. If you decide to hire that lawyer, make sure you receive a written contract stating what all of the costs will be. Your lawyer may have to hire an investigator or an expert, and the costs may be passed on to you. You should require your approval of any additional costs that are incurred after the signing of the contract. Remember, the hiring of an attorney is an important decision that should not be based solely upon advertising or placement on a list such as this. Before you decide on an attorney ask for free written information about the firm, its qualifications and experience.
