If you decide to hire that lawyer, make sure you receive a written contract stating what all of the costs will be. Your lawyer may have to hire an investigator or an expert, and the costs may be passed on to you. You should require your approval of any additional costs that are incurred after the signing of the contract. Remember, the hiring of an attorney is an important decision that should not be based solely upon advertising or placement on a list such as this. Before you decide on an attorney ask for free written information about the firm, its qualifications and experience.
