**ADMINISTRATIVE ORDER A-2021-030  
(Amends Administrative Order A-2020-055)**

**JUDICIAL ASSIGNMENTS**

Florida Rule of Judicial Administration 2.215(b)(4) empowers the chief judge to assign judges to the courts and divisions and to determine the length of each assignment. Rule 2.215(b)(5) authorizes the chief judge to designate administrative judges of any division to assist with the administrative supervision of the division. Rule 2.215(b)(2) provides that the chief judge may enter and sign administrative orders. In light of the Honorable Art McNeil's forthcoming judicial retirement and until the governor's upcoming judicial appointee assumes the bench, it is necessary to reassign a county judge and use senior judges for temporary coverage.

By the power vested in the chief judge under article V, section 2(d), Florida Constitution; section 43.26, Florida Statutes; and the above-referenced judicial administration rules, it is ORDERED:

**CIRCUIT COURT  
East Circuit Division**

*Art McNeil* is assigned to East Circuit Division "S" (Protective Injunctions) through May 31, 2021. Effective June 1, 2021, *Monique M. Scott* is assigned to East Circuit Division "S" (Protective Injunctions).

*Art McNeil* is assigned to East Circuit Division "U" (Probate and Guardianship) through May 31, 2021. Effective June 1, 2021, *Monique M. Scott* is assigned to East Circuit Division "U" (Probate and Guardianship).

**COUNTY COURT  
County Civil Division**

*Monique M. Scott* is assigned to County Civil Division "J" through May 31, 2021. Effective June 1, 2021, senior judges are temporarily assigned to County Civil Division "J."

**East County Division**

*Art McNeil* is assigned to East County Criminal Division “P” through May 31, 2021. Effective June 1, 2021, *Monique M. Scott* is assigned to East County Criminal Division “P.”

*Art McNeil* is assigned to East County Civil Division “Q” through May 31, 2021. Effective June 1, 2021, *Monique M. Scott* is assigned to East County Civil Division “Q.”

**ADMINISTRATIVE JUDGES**

*Art McNeil* is designated as administrative judge of the East County Division through May 31, 2021. Effective June 1, 2021, *Richard A. Weis* is designated as administrative judge of the East County Division.


**Effect on Previous Administrative Order**
