**ADMINISTRATIVE ORDER A-2026-026
(Amends Administrative Order A-2025-060)**

JUDICIAL ASSIGNMENTS UPDATE

Florida Rule of General Practice and Judicial Administration 2.215(b)(4) empowers the chief judge to assign judges to the courts and divisions and to determine the length of each assignment. Rule 2.215(b)(2) provides that the chief judge may enter and sign administrative orders.

By the power vested in the chief judge under article V, section 2(d), Florida Constitution; Florida Statutes section 43.26; and the above-referenced rules of judicial administration, it is ORDERED:

Emily A. Peacock is assigned to Juvenile Dependency Division “J” (Family Dependency Treatment Court).

COUNTY COURT

County Civil Division

Effective August 24, 2026, *Daryl M. Manning* is assigned to newly created County Civil Division “X.” See Administrative Order S-2026-021 (*Establishment of County Civil Division “X”*).


County Criminal Division
