

The Children's Justice Center (CJC), created in 1992 under the direction of the Thirteenth Judicial Circuit Court, provides programs to help child victims of sexual and physical abuse and children who have witnessed crimes. Programs provided are:




Children are interviewed by CAC professional forensic interviewers with knowledge of child development, in an age appropriate "child-friendly" room. The CAC conducts over 600 one on one investigative interviews and depositions each year. Further, the CAC provides the facilities and technology for law enforcement and investigative professionals to participate in the interview via closed circuit television and through wireless audio equipment. The interview is captured on videotape, thus reducing the number of times the children must relive their horrid experiences.


2) The Supervised Visitation Program:

A safe environment for children in the care of the Department of Children and Families or other guardians to maintain contact with their non-custodial parents amidst allegations that the children's safety would otherwise be jeopardized. Judges order these visitations in criminal, domestic violence, family law and dependency cases. Over three thousand visits occur each year. The CJC provides the visitation facilities, scheduling, supervision, toys and videotaping of the visits.

The Outreach Program:

Providing up to date training on "How to Talk to Children" for law enforcement's first responders at the scene of the investigation and promotes child abuse awareness and prevention in community forums.





The Children's Advocacy Center Foundation supports all of the CJC programs. Funds raised by the Children's Advocacy Center Foundation:

Allow the professionals at the CJC to attend advanced educational classes in child abuse investigative techniques, forensic interviewing techniques, child development, and crisis intervention skills for children suffering from sexual and physical abuse trauma.

Enable the CJC to create a child friendly atmosphere with vividly painted walls, enchanting décor and a variety of toys appropriate for babies through the teen ages.

Provide a new stuffed animal to each child to keep following the forensic interviews.
