2. This Court orders that the Sheriff take the Defendant into custody, if found in the State of Florida.

This Court further orders that the Sheriff hold Defendant in safe keeping, and produce Defendant before a first appearance judge within 24 hours of Defendant's detention, so that the first appearance judge may order the Hillsborough County Sheriff's Office to produce Defendant to this Court on the following business day or, if the following business day is a

Saturday, Sunday, or legal holiday, on the next business day following, whereby Defendant shall be provided an opportunity to comply with this Court's Order to Show Cause and otherwise purge himself/herself of Contempt.

4. This Court further orders that the Hillsborough County Sheriff's Office shall notify this Court of the Defendant's detention and the execution of this Writ no later than 4:00 p.m. the day after the Defendant is first detained or, if the day of initial detention is a Saturday, Sunday, or legal holiday, on the next business day following.
